- Meet CASA medical requirements.

Please note that the above does not include the following incidental fees, which must be covered by the student:

- CASA testing fee. Cost published by CASA on www.casa.gov.au **(Non Tuition fee)**
- ASIC Card. Cost published by CASA on www.casa.gov.au **(Non Tuition fee)**
- Medical Licence Fee. Fees vary by medical examiner **(Non Tuition fee)**
- Uniform – Approximate cost is \$350.00 **(Non Tuition fee)**
- Flight Cancellation Charge – When a student does not attend a scheduled flight, or cancels the flight with less than 24 hours notice, a charge of \$50 per hour of the flight booking will be made to the student. **(Non Tuition fee)**
- IREX Textbook - \$259 **(Non Tuition fee)**
