- Already hold a CASA issued Commercial Pilot Licence
- Already hold either a CASA issued Night VFR or CASA issued Instrument Rating , and

- Meet CASA medical requirements.

Please note that the above does not include the following incidental fees, which must be covered by the student:

- CASA testing fee. Cost published by CASA on [www.casa.gov.au](http://www.casa.gov.au)
- ASIC Card. Cost published by CASA on [www.casa.gov.au](http://www.casa.gov.au)
- Medical Licence Fee. Fees vary by medical examiner.
- Uniform – Approximate cost is \$350.00
- Flight Cancellation Charge – When a student does not attend a scheduled flight, or cancels the flight with less than 24 hours notice, a charge of \$75 per hour of the flight booking will be made to the student.
- The Pilot Support Pack includes the CASA flight test fee, PMI Textbook and the CASA theory exam fee. The price is \$1,310 for students flying the Cessna 152 and \$1,370 for students flying the Warrior.
